Women's March San Diego Demands Racial Justice Now

Across the nation and globally, protests calling for racial justice continue. Like you, we are heartsick from the latest murders of Black Americans Ahmaud Abery, Breonna Taylor, George Floyd, and the many others, named and unnamed. We see and center the pain of the Black community, for whom this violence is not new. The pain we feel is evidence that white supremacy harms us all and must fuel our Anti-Racist work and our affirmative, unequivocal rejection of racism. The civil unrest that has unfolded this week is the result of the long and complicated history of our country; one of oppression and dehumanization, of systemic racism and racial injustice. This is the America we created. We must do better.

The Women's March movement was born of collective protest - a reaction to the outcome of the 2016 Presidential election. This week, San Diegans joined in protests throughout the County and we saw the impact of these protests in the announcement of a long awaited ban on the use of carotid restraints by the San Diego Police Department, followed by the San Diego County Sheriff's Department, along with several more cities. This first and important step is a precursor to the November initiative on an independent commission for more effective police oversight.

Unity principles bind our movement, and include value statements on Civil Rights and Ending Violence. We stand firm in our rejection of language or action from any person or group that targets, disparages, denigrates, threatens, or harms another person or group. Every person deserves to live a full and healthy life, free of all forms of violence. We believe in accountability and justice in cases of police brutality and ending racial profiling and targeting of communities of color. Our work must be undertaken in our hearts and in our families, in our schools and workplaces, in our houses of worship and government. We know it is our moral imperative to dismantle the gender and racial inequities within the criminal justice system and these are critical steps within our community.
